The Ludwig Boltzmann Institute of Fundamental and Human Rights, in cooperation with five partners across the European Union, is implementing the project “[JUSTICE FOR ALL](#)” with a view to better understanding the situation of defendants and detainees with psychosocial and/or intellectual disabilities vis-à-vis international, regional and national human rights standards and their (ill)-application in the context of criminal proceedings.

After two years of research on the national and international level and consultations with stakeholders from different disciplines (including judges, prosecutors, lawyers, representatives of NPMs and other oversight mechanisms, medical experts, social workers, probation officers as well as other relevant actors), we are pleased to present our findings at the Final Conference.

Our research was structured around three thematic areas: procedural safeguards and accommodations of persons with intellectual and/or psychosocial disabilities, treatment and conditions during deprivation of liberty and alternative measures to deprivation of liberty and probation. The project further focuses on EU cross-border proceedings relating to [European Arrest Warrant](#), [Transfer of Prisoners](#), [Probation and Alternative Sanctions](#), or the [European Supervision Order](#) for persons with intellectual and/or psychosocial disabilities.
